**NIC Interview Preparation:
Decision-Making and Decision-Explaining

9:00 a.m. – 5:00 p.m.**

This workshop will provide participants with opportunity to become familiar with the domains on the RID NIC Interview Rubric and to practice for the interview portion of the NIC exam. Participants will learn how to think globally and identify critical elements that must be included in high quality responses. Working in triads or dyads, participants will practice answering interview questions following the format of the NIC exam. Pre-requisite: Participants must have passed the written portion of the NIC exam or hold other RID certification.

Workshop limited to 10 participants.

What to bring: Participants need to bring the following documents to the workshop: 1) RID Code of Professional Conduct, 2) RID NIC Interview Rubric Anchor, and 3) RID NIC Interview Examination Suggested Reference Materials list. These documents are available on the RID web site, www.rid.org. 3) Digital video camera to record your work.

Notes: 1) There will not be hands-on practice for the Performance portion of the exam. 2) This workshop does not cover other RID exams.
